SURFACE PREPARATION | APPLICATION

As stated by DTU 59.1, all surfaces must be clean, dry and free of dirt.
Old glossy painted surfaces must be previously sanded or washed with an appropriate cleaner and then rinsed with water.
In the presence of contaminants such as mildew, molds or bacteria, apply an anti-fungal treatment named IKAR AM.
These recommendations do not override a specific description of the substrate.

Primer coat	Apply 1 coat of PRIM O 2010	Apply 1 coat of IKARPRIM
Top coat	Apply 1 or 2 coats of AQUASTRIA MAT depending on the substrate

Storage	Can be kept for 1 year in unopened original container. Protect from freezing and high temperatures.
